## MEMORANDUM OF UNDERSTANDING



This MEMORANDUM OF UNDERSTANDING (MoU) made and entered into on 30th December 2017 by and between following parties:

- A. Dr. B.R. AMBEDKAR UNIVERSITY OF SOCIAL SCIENCES (BRAUSS), Dr. Ambedkar Nagar (MHOW) which expression shall mean and include its successors in interest and assigns of the first part (hereinafter referred to as BRAUSS), AND
- B. MADHYA PRADESH POLICE ACADEMY, BHOPAL which expression shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as MPPA)

### **Preamble:**

WHEREAS BRAUSS, and MPPA are interested in entering into an MoU with a view of sharing a common desire to explore, extend and strengthen the functional relationship including Academics, Research, Extension and Training in order to share the facilities and expertise available with each of them, herewith, sign this MoU on certain broad understanding.

### **Purpose and Scope:**

1. Both **BRAUSS** and **MPPA** would be recognized as Study and Research centres for conducting short term and specified duration courses and academic programmes, including teaching, research, extension and training activities.
2. Certificate, Diploma, Graduate Degree, Post Graduate Diploma, Post Graduate Degree and Research Degrees- M.Phil. and Ph.D. will be awarded by BRAUSS in subjects/ disciplines as decided mutually by BRAUSS and MPPA and as provisioned in relevant Ordinances and Regulations of BRAUSS.
3. Initially, 2 years Master of Arts (Police Administration) Programmes will be started on credits based semester system having equal weightage for theory and practical's, including internal, external, field training, and dissertation. If the course is not successfully completed in the stipulated time, one more attempt will be given for the same. If the candidate is still not able to successfully complete the course, one mercy attempt, with the mutual consent of both MPPA and BRAUSS may be given. However, the entire programme must be completed in a total of 4 years.
4. The necessary action and formalities for the above said degree, Master of Arts (Police Administration) will be taken care by the BRAUSS. Such as, permission for the degree, formalities with the UGC and necessary formalities for the above said degree like notifying ordinance/ amendments will be done by the BRAUSS.

### **Roles and Responsibilities:**

5. An academic committee under the Chairmanship of the Dean, School of Law & Social Justice, Course Director, MPPA, Course Coordinator, BRAUSS and having nominees each from the Vice Chancellor, BRAUSS and Director, MPPA and as provisioned in the relevant Ordinance of BRAUSS will approve the course structure, modalities, syllabus, course contents and all necessary requirements for the degree course.
6. Officers and Staff working in different Cadres as trainer and duly nominated police officers/employees of Madhya Pradesh Police can be admitted and enrolled for Graduation, Post Graduation, M.Phil. and Ph.D. degrees as the case may be, to be awarded by BRAUSS, provided the candidates fulfil the eligibility norms and pass the selection test conducted by the Competent Authority at MPPA/BRAUSS as decided by a joint committee for the purpose.
7. Examination to the concerning degrees/ diplomas including admission test, if any, will be conducted by BRAUSS at the Examination Centre of MPPA.

8. The centre of course work for examination will be MPPA and dates would be mutually decided by committees constituted for the purpose. Admission and registration will be governed by UGC Rules, Norms and the University Regulations (including amendments). BRAUSS may also be an alternate centre of examination, if & when required.
9. The faculty, officers, scientists of MPPA /BRAUSS if needed, may invariably take part in teaching programme of either Institutions in every academic year as worked out (as per specialization for the benefit of students) topic of lectures and days/time will be fixed by mutual consultation, subject matter of approval by the competent authority i.e. Director of MPPA/Registrar, BRAUSS.

**Process and Procedure:**

10. The Selection of candidates, teaching & training will be done by the MPPA and their admission, enrolment, examination and degree will be awarded by BRAUSS.
11. Enrolled students will have to pay course fee as per the norms of BRAUSS.
12. After admission and immediately after 45 days Foundation Course, one week mandatory orientation course will be held in BRAUSS on "Aim, Objectives, Modalities and Credit-Semester System Requirements for Master's Degree Programme in Police Administration".
13. Two seminars (3 to 5 days) one each in MPPA and BRAUSS, will be held during the course as per mutually decided dates. Credits and certificates shall be awarded for participation.
14. The TA/DA allowances and honorarium will be payable to the invited guest faculty members /officers as per the norms of M.P. State Govt.
15. Travel allowances and D.A. on the visits of Faculty/Scientists or for any academic discussion/ Research Degree Committee meeting/Ph.D. viva-voce, examination of the students of the either institutions will be met from the resources of the respective Institutions.
16. The students working in either Institution will be allowed to carry out entire or part of their studies/research work in the various laboratories of MPPA or BRAUSS and both Institutions will extend all necessary facilities, consumables & expertise to the research students on payment of charges as prescribed by the University/Academy providing the facility with due permission of the Director of MPPA/ Registrar, BRAUSS.
17. The feed-back after every course shall be sent to the Director of MPPA/ Registrar, BRAUSS in time.

### **Research and Development:**

18. The Faculty, Officers, Scientists of BRAUSS and MPPA may apply for and/or conduct joint collaborative research projects and patents to National and International funding agencies on issues like police reforms, positive image building of police, competent mapping, community leadership, sustainable development, cyber laws, IT related crimes, Information Security, changing perspective in criminal justice, paralegal issues, role of police in disaster management and human rights protection.
19. Data generated through such collaborative research will be published in peer reviewed journals jointly by the faculty of both the Institutions.
20. In the existing Intellectual Property regime, techniques, technologies, materials etc. developed/perfected which may be of immediate or likely commercial value would be the joint property of both Institutions. The Intellectual property claims/formalities would be filed/made jointly by mutual consultation except/ barring materials of the BRAUSS or MPPA.
21. Collaborative applied research programme as per respective mandate and objectives of both Institutions would be taken up by the Faculty, officers, Scientists of both the Institutions.
22. Cooperate in the exchange of scientists and researchers to encourage sharing of experience, scientific knowledge, and technology advances, FSL laboratories, and its dissemination or expansion among the masses/societies.
23. Results of the collaborative research will be jointly published in the public interest as mutually agreed upon and related Research, PhD, Dissertation Papers and any form of Publication for which both of the faculty contributed directly or indirectly, will be the joint ownership of MPPA and BRAUSS.
24. All research materials used in the collaboration will be transferred using Material Transfer Agreements (MTAs). Either party may use such materials, but will give due credit to the source of the materials.

### **Continuity and Confidentiality:**

25. The MoU will be initially effective for the period of 10 years from the date of entering into it, which can be renewed for another 10 years by mutual consent.



This memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is given by the notifying party to the other party before thirty (30) days of the date on which the termination or the amendments is intended to become effective. The commitments, made before the date of termination of MoU, will continue to be operative till the end of the course for which enrollment has been done.



## MEMORANDUM OF UNDERSTANDING



This MEMORANDUM OF UNDERSTANDING (MoU) made and entered into on 8th March 2019 by and between Dr. B.R. AMBEDKAR UNIVERSITY OF SOCIAL SCIENCES, Dr. Ambedkar Nagar (BRAUSS), and MADHYA PRADESH POLICE ACADEMY, Bhopal (MPPA)

WHEREAS BRAUSS and MPPA are already in agreement under Memorandum of Understanding [MoU] signed on 30th December 2017, and in addition to mutually agreed terms and conditions therein, are further interested in expanding the academic interaction to conduct the following programmes from the academic session 2019-2020:

1. **Master of Arts [MA] Degree in Police Management** of two years (in four semesters) for Police Inspectors and Sub-Inspectors, which would be a mandatory degree programme for all new probationers of MPPA.
2. **Post Graduate Diploma [PGD]** of one year [in two semesters] in Police Administration/ Police Management/ Criminology/ Victimology and Victim Justice/ Forensic Science/ Cyber Crime/ Human Rights/ Criminal Justice/ Computer Applications/ Democratic Policing/ Special & Local Laws, which would be open for all Police Officers interested in specialization.
3. **Certificate Courses** of six months in Police Administration/ Police Management/Humanitarian Laws/ Intellectual Property Rights/ Crime Mapping/ Counter Intelligence/Human Trafficking.
4. The necessary academic formalities including Ordinance for the above said degrees and programmes, shall be taken care of by the BRAUSS and necessary administrative approvals and permission shall be taken care of by MPPA.
5. The Selection of candidates, teaching & training in collaboration with BRAUSS shall be done by the MPPA and their admission, enrolment, examination and degree shall be awarded by BRAUSS. Enrolled students shall have to pay course fee as per the norms of BRAUSS.
6. The MoU will be initially effective for a period of 10 years from the date of entering into it, which can be renewed for another 10 years by mutual consent.
