

Ambedkar Nagar (Mhow) through its ______ Indore here in after referred to as "BRAUSS" (Which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) of the FIRST PART

AND

Pithampur Auto Cluster having a skill development centre named Advance Technical & Industrial Training Center, situated at 113/2 B, Village Harnia Khedi, A.B. Road, Opp. Veterinary College, Tehsil Mhow through its principal here in after referred to as "ATITC" (Which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) of the SECOND PART.

Dr. B. R. Ambedkar University of Social Sciences and Pithampur Auto Cluster, may hereinafter collectively be referred to as "Parties" and individually as "Party"

BACKGROUND AND PURPOSE

ATITC is a premium training institute of Pithampur Auto Cluster, a Government of M. P. Undertaking, engaged in the skill development activity and carrying Short/Long term vocational training programs. As per the common/standard norms after the completion of such training programs third party assessment and certification is essential. Hence for this purpose ATITC has approached BRAUSS and in return BRAUSS has agreed to carry evaluation of students trained by ATITC.

NOW IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:

- That the Second Party will provide necessary information of trainees, including the course curriculum and such other information as may be required by the First Party in timely manner.
- That the Second Party will make all arrangements at the center such as raw material, lab facilities and necessary infrastructure to conduct the assessment.
- That the admission, exam and diploma/degree will be processed by the university.
- That the First Party shall carry out the evaluation & examination of the trainees and award certificates/Diploma/Post Diploma to the students trained by the Second Party.
- That the First Party will ensure timely completion of training assessment & certification of trainees, trained by the Second Party.
- That the Second Party shall make payment of assessment cost as per the standard norms on timely manner to the First Party for all the students for which the First Party shall have given acceptance against requisition.
- That there will be no financial liabilities on university, however assessment fees as applicable will be paid in favour of university.
