



2. Executive Diploma in Business Valuation (EDBV)

This Diploma aims to develop proficiency in valuing assets and liabilities through a learning process that blends concepts with applications. The participants will get extensive exposure through project work on valuation and by analyzing case studies.

Duration: 6 Months, Fees: Rs. 30,000 plus applicable GST,

Coaching: Online & Offline

3. Certificate Course in Arbitration (CCA)

The objective of this course is to familiarize the participants with legal framework of arbitration, arbitration procedures, and arbitration practice.

4. Certificate Course in Goods and Services Tax (GST)

(C) COST AND MANAGEMENT ACCOUNTANCY EXAMINATION

With the globalization of all economic activities, the industries both in manufacturing and service sector have recognized the potential of Cost and Management Accounting profession in giving support in effective resource management and making the operations more cost effective for facing the challenges of management.

CMA Course is divided into 3 parts:

- Foundation Course (Coaching Oral/Postal, Fees: Rs. 4,000/-)
- Intermediate Course (Coaching Oral/Postal, Fees: Rs. 20,000/-)
- Final Course (Coaching Oral/Postal, Fees: Rs. 17,000/-)

- (v) Jointly conducting Online Commerce Olympiad for class XI and XII students designed by ICAI primarily at Madhya Pradesh and then PAN India jointly by ICAI and Dr. B. R. Ambedkar University of Social Sciences, Dr. Ambedkar Nagar (Mhow)-453441, Indore (M.P.).
- (vi) For promoting and conducting for Capsule Courses at College level (Graduation level) designed by ICAI for enhancing employable skills of the students
- (vii) To conduct short term Certificates Courses for Corporate Houses / Industry people designed by ICAI
- (viii) To conduct Entrepreneurship & Skill Development Programme designed by ICAI
- (ix) Conducting various joint Seminars & Workshops
- (x) Conducting Joint Activities/Studies/Projects on various social sectors as may be agreed upon and reporting/submitting the findings of the study to the Government;

ABOUT THE COURSES

(A) CAT Course

Objective:

To meet the huge demand for entry level Accountants in India, ICAI has launched a short term Course - Certificate in Accounting Technicians (CAT) for 12th (10+2) passed and Under Graduates. This Course has been introduced in consultation with Ministry of Corporates Affairs, Government of India. CAT equip students become well versed with the maintenance of accounts, preparation of Tax Returns, Filling of Returns under Companies Act, Filling of Returns under Income Tax, GST, Custom Act, Export & Import documentation etc.

Eligibility: The Students who have passed/appearing 12th (10+2) examination are eligible to take admission in Foundation (Entry Level) Part-I of CAT Course.

Course Fees: - Rs. 9800/-

Mode of Examination: Multiple choice question to be answered on-line.
