<b>Definitions</b>	1. All words and expressions used herein shall have the same meaning as assigned to them in Dr. B. R. Ambedkar University of Social Sciences, ACT, 2015
<b>Provision under the University ACT for establishment of Schools of Studies</b>	<p>2. There shall be such number of School as determined by the Governing Body and such number of Centres and Departments of Studies as determined by the Executive Council from time to time, as provided in Section 27(1) of the University Act 2015.</p> <p>All Schools of the University shall be established to achieve the aims and objectives of the University in order to accelerate higher education, research and extension and training in all aspects of social sciences and other disciplines for educational excellence and socio-economic development of Scheduled Castes, Scheduled Tribes and Other Backward Classes as envisioned by Dr. B. R. Ambedkar.</p>
<b>Schools of Studies of the University</b>	<p>3. Without prejudice to the foregoing provisions, the University shall initially have the following Schools of Studies -</p> <ul style="list-style-type: none"> <li>(i) School of Dr. Ambedkar's Thoughts and Philosophy;</li> <li>(ii) School of Social Sciences and Management Studies;</li> <li>(iii) School of Agriculture and Rural Development;</li> <li>(iv) School of Education and Skill Development;</li> <li>(v) School of Law and Social Justice.</li> </ul>
<b>Schools of Studies - Academic Structure</b>	4. Every School shall consist of Interdisciplinary and multidisciplinary Departments.

	<p>5. All teaching faculty members and research staff of the University, its Directorate or Centre or Institution including any of the <i>Samajik Vigyan Kendra</i> shall be posted in Directorate and Schools as the care may be</p> <p>6. Non-teaching supporting staff shall be appointed to support the academic, research, extension and training activities and such other duties as directed by the competent officer.</p> <p>7. Every School shall have a Dean who shall be the academic and administrative head of the School and who shall be appointed in the manner as prescribed in relevant Regulation.</p> <p>8. Any faculty member or staff deputed in a School could be transferred to any other School or Directorate or Centre or Institution including any of the <i>Samajik Vigyan Kendra</i> of the University, by the competent authority.</p>
<b>Schools and their Departments</b>	<p>9. Every School of Studies shall consist of such Departments as shall be assigned to it by relevant Ordinance.</p> <p>10. All Departments under all Schools of the University shall be interdisciplinary and multidisciplinary in nature and shall be established to achieve the aims and objectives of the University in order to accelerate higher education, research and extension and training in all aspects of social sciences and other disciplines for educational excellence and socio-economic development of Scheduled Castes, Scheduled Tribes and Other Backward Classes as envisioned by Dr. B. R. Ambedkar.</p> <p>11. All faculty and equivalent research staff in all Schools including Dean, Professors, Associate Professor, and Assistant Professor shall impart interdisciplinary and multidisciplinary class room teaching, video conferencing/ field and conduct research, extension and training activities so as to fulfil the mandate and objectives of the University.</p> <p>12. All teachers and equivalent research staff of Schools including Dean,</p>



	<p>Professors, Associate Professor, Assistant Professor besides their assigned academic and professional duties shall impart teaching in the compulsory papers.</p> <p>13. All teachers and equivalent research staff of the University shall have to attend refresher and orientation courses in subjects as per the mandate and objectives of the University, and in particular any of the two such interdisciplinary and multidisciplinary courses from amongst the following courses :</p> <ol style="list-style-type: none"> <li>1. Dr. Ambedkar Thoughts and Philosophy (ATP)</li> <li>2. Research Methodology and Statistics (RMS)</li> <li>3. Indian Constitution and Social Change (ICSC)</li> <li>4. Social Emancipation &amp; Justice, Economic Empowerment &amp; Development, Educational Excellence and Participation of SCs, STs &amp; OBCs in Decision Making and Nation Building (SEEP)</li> <li>5. Emerging Dimensions of SCs, STs &amp; OBCs Development, Implications and Temporal Significance (EDD)</li> <li>6. Computer Education and use of ICT</li> </ol>
