## Indicative Guidelines for Preparing a Research Proposal for a Research Project

Research report will be in A4 size page. The text of the report will be in 12 font size, main heading in 16 font size and sub-headings in 14 font size. Times New Roman & Kruti Dev 055 should be the font type. Research can be done in Hindi / English Language

## Discipline of the Project

- **Title:** The title of the project should be concise (with sub-title, if any) reflecting the scope of the investigation
- Arrange all pictures in accordance to the life history of Maharana Pratap with a brief annotation in Hindi. The Photos needs to be supported by details about description of photos, Year/period of Occurrence
- Research scholar has to collect more than 300 pictures from all published and unpublished sources and needs to submit 3 photos for each picture So that best can be choose
- Project has to be submitted in Printed format and in digital format of high resolution
- Specification of Photo Album (Printed/Digital)

Album: High Quality Photo Album, Size of album: 18 inch width and 14 inch length, Water Proof, resistance to Tear, Photo: High resolution digital photo, 10 full size photo and other photos size 5 to 7 inch (Total number of photos: 300), Cover Design: Sketch of Maharana Pratap engraved on cover Printing: High quality Photo print on double side, Paper Quality: Glossy Paper, Perfect binding with lamination .Online Digital Album: High resolution photos which shall not blur while enlarging pic

• References: the proposal should include a list of references mentioned in the textalong with other important recent additions to the literature on the theme. The references should indicate the author, title, publisher and year of publication. The APA style should be followed for reference citations.

- 1. A Book-length final Report in a publishable form along with an Executive Summary of the report (5000 words). Both documents should be submitted in hard format (two copies of final report and five copies of summary) and soft copy of the same (in pen drive).
